



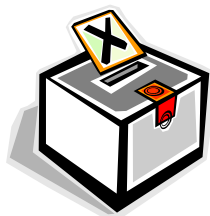

- **Photo ID Required**
- **Qualified voters must be:**
 1. A United States citizen, at least eighteen (18) years of age.
 2. A resident of Joint School District #60 for at least thirty (30) days preceding the date of election.
 3. A registered voter. (You may register at the polls. You will need a picture ID and proof of residence.)

What is a supplemental levy?

- A supplemental levy is a 2-year levy used for the general maintenance and operations of the school district. This includes personnel and student programs.

What margin of approval is required to pass this supplemental levy?

- This supplemental levy will need a simple majority to pass (50% + 1 vote).

Why does the district need to continue the supplemental levy?

- Increased costs of salaries, insurance, school safety, and the rising demands of special services as required by federal law.

Is the School District asking for an increase in the supplemental levy renewal?

- **NO.** Shelley School District has had a supplemental levy for the past twelve years.
- We are asking for your **continued** support to **renew** the existing supplemental levy in the amount of \$575,000.

Will my property tax levy rate increase if the supplemental levy is approved?

- No, our tax levy rate for the supplemental levy will decrease from .00087 to .00073 because our overall market value has increased.

How will your levy dollars be used?

- Maintain current programs and operational costs.
- Enhance and update curriculum.
- Provide additional support for activity, athletic, music and performing arts programs.
- Continue to absorb many of the fees associated with registration.
- Supplement wages and insurance for all staff including: paraprofessionals, bus drivers, food service, teachers, technology & maintenance staff.
- Maintain educational excellence currently in the Shelley School District.
- Supplement increasing technology costs.

What happens if the levy does not pass?

- The School Board would be required to review and modify the District's budget to determine probable reductions in personnel and/or offered programs necessary to balance the budget.

How does the Shelley School District supplemental levy compare with surrounding districts?

- 81% of Idaho districts depend on supplemental levies to compensate for inadequate financial support from the State.
- With **renewal** of a \$575,000 levy, Shelley School District would still have one of the **lowest** levy amounts per student.

What is the question on the ballot?

Shall the Board of Trustees of Joint School District No. 60, Bonneville and Bingham Counties, State of Idaho, be authorized and empowered to levy a Supplemental Levy in the amount of five hundred and seventy-five thousand and no/ dollars (\$575,000.00) per year for two (2) years, commencing with the fiscal year beginning July 1, 2022 and ending June 30, 2024, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on December 16, 2021?
